To enhance the State management role, properly and promptly collect and timely collect the right subjects, manage well the revenue sources, cover all sources of revenue and combat losses arising in the localities.

Improve the organizational capacity and management of the machinery of tax collection, including professional qualifications, ethical qualities of officials, investment in equipment for tax collection.

To fully exploit the advantages of border gates with China, especially Thanh Thuy border gate. This will increase the revenue for the provincial budget. The customs authorities must closely coordinate with the functional branches, including police, taxation, transportation, market management, to perform the inspection work such as coding, imposing tax rates. Timely detecting unreasonable errors in the collection work, strengthening the fight against smuggling and trade frauds and strictly control the stamping of high-tariff items.

At the same time, the structure of reasonable expenditures, especially the expenditures on development investment.
